Answer: Net operating cashflows for the last several quarters have been impacted by elevated expenditure relating to study and financing costs for the Citronen Project. With a decision pending by EXIM Bank on it's initial credit decision in the current quarter, further elevated expenditure is subject to that decision and net operating cashflows may subsequently be different in future quarters.
